Padraig Harte, IT Sligo



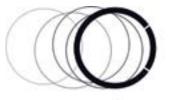

Declan serves as Ireland's representative on the European Commission's Multi-Stakeholder Forum on elnvoicing.

Prior to his appointment he held a range of technical and senior management positions in the IT/ eProcurement industry and, as a member of the National Standards Authority (NSAI), has served on the European eProcurement Standardisation task force (CEN/TC434) that was charged with drafting the elnvoicing Standard as referenced by the European elnvoicing Directive (2014/55/EU).
